## **MINUTES**

HAMFest 2021 – October 16, 8AM – 1PM, at Our Savior Lutheran Church.

Need to sell tables - \$10 on the lot, \$15 inside with 22 available spaces.

General admission will be \$5. There will be a raffle prize drawing and a 50/50 pot. The following details were discussed:

- Set-up will be done the night before. Lots of volunteers will be needed.
- Food will be prepped and sold in the shelter area.
- Rear entrance will be the only available entrance into the building.
- Contact Richard to reserve your table.
- Admission table will be set up inside.
- Scott Anderson, KJ4MFW, has a P.A. system that can be used.
- More details will be discussed at the August club meeting.

A motion was made to purchase a banner for HAMFest. Don Weldon, KFOARQ, moved. Tom, KDOOPV, seconded. After discussion, motion was withdrawn until more details about the price, dimensions, and information on the banner could be decided on.

# SET (Simulated Emergency Test)

Scott, KJ4MFW, shared background information about what SET is. Various possible emergency scenarios can be used. Scott has participated in 15 SETs in the past 10 years and is willing to coordinate with the ARES team. There is a scorecard similar to Field Day with various points awarded for different elements in the test. After discussion, the decision was made to wait until after HAMFest to conduct the SET, October 30 from 9-11AM followed by lunch. A motion was made to proceed with plans for the SET with Scott, KJ4MFW, coordinating. John, NOXG, moved. Dennis, KY0P, seconded. Motion carried.

### **DMR REPEATER**

Steve Semon, KEOCYW, shared details about a possible new repeater in Benton County, south of Cole Camp on Highway W. Steve owns the tower and has the equipment needed. This repeater would have DMR capabilities, but can also be used analog. To use DMR, you must have a DMR radio. The equipment would be at no cost to the club, but there will be internet fees that will need to be considered. This will be discussed further once the system is ready. Steve shared he is currently awaiting frequencies from the FCC.

### **CLUB DONATION**

Doc, W3MEB, shared that he has been working with Rick, KD0CNC, on acquiring a communications trailer to be donated to SPARK. The trailer is currently outfitted with antennas, but does not have all the radio equipment needed. A condition was made that upon accepting the trailer the club would agree that the trailer would not be government controlled.

A motion was made to accept the communications trailer as club property with the condition that it would be owned and operated by SPARK with no government agency involvement in the use of the trailer, with Doc, W3MEB, and Rick, KD0CNC, to be co-trustees. Rick declined, so the motion was amended for Paul, KD0ETL, to be the co-trustee with Doc. Rex Green moved, Donald Finch, AD0VD, seconded. Motion carried.

Additional details were discussed. The trustees will have a report at the next meeting regarding registration and insurance on the trailer.

Connie, WAOQCJ, shared interest in purchasing logo wear. If any other members are interested, she can provide information she received from a local vendor.
